I AGREE to release the Federation, R&BEC and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Federation, R&BEC or the Competition. I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Federation, R&BEC or the Competition. I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Federation, R&BEC and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition. I have read the Federation and R&BEC Rules about protective equipment, including GR318 and EV113, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation and R&BEC strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.
